

In the process of becoming a dealer at Anime 2016, all parties involved will sign the Anime 2016 dealer contract. The terms of said contract are described below.

Based on the contract, the dealer and the J-POP Foundation agree that:

1. The dealer will rent the commercial space, tickets and other items as specified in order ORDERNR for Anime 2016 to be held from Friday the 10th of June 2016 through Sunday the 12th of June 2016 in the World Forum Convention Centre in The Hague, The Netherlands.
2. The dealer will make sure the commercial space is in use during the opening hours of the dealer room. The dealer room will be open on: Friday from 17:00 till 22:00, Saturday from 10:00 till 19:30 and Sunday from 10.00 till 16.30 or until a mutually decided time at any of these days.

[POINT 3 FOR THE DEALER TARIFF GROUP]

3. The dealer will abide by the location and festival rules and will sell only products legal in the Netherlands; but no chewing gum and no fresh, cold or warm food and no fresh, cold or warm drinks.

[POINT 3 FOR THE ARTS & CRAFTS, TRAVEL AGENCIES AND LANGUAGE SCHOOL TARIFF GROUP]

3. The dealer will abide by the location and festival rules, may not sell any food or drinks and will sell only self-made goods or travels, holidays, trips, travel guides, educational courses and/or language books.

[POINT 3 FOR THE DOUJIN & SMALL PRESS TARIFF GROUP]

3. The dealer will abide by the location and festival rules, may not sell any food or drinks and will sell only products based on the dealers own art.

[POINT 3 FOR THE CONVENTIONS TARIFF GROUP]

3. The dealer will abide by the location and festival rules, may not sell any food or drinks and will sell only tickets to their convention and convention related merchandise. Other items may only be sold after prior agreement of the J-POP Foundation.

[CONTINUING FOR ALL TARIFF GROUPS]

4. The total amount due for rent and tickets amounts to AMOUNT Euros and must be paid in advance. The dealer has the following payment options:

  - Paid in advance in cash (NO payments during the festival)
  
5. Unless other terms were agreed upon in writing from the J-POP Foundation, payment has to be made 40 days before the festival. The J-POP Foundation reserves the right to re-allocate the space without notice after this period.
  
6. The dealer guarantees the J-POP Foundation that all material made available to the attendees is in agreement with applicable laws. This means that, amongst others, the dealer is not allowed to sell imitations or bootlegged products. The dealer will be accountable for any legal cost following non-compliance with these rules. The police will be notified if counterfeit products are being offered.

By signing the agreement, the dealer confirms to have read the general terms set by the J-POP Foundation, as found on the following pages and will accept these unconditionally.
